- 2. Admissions after 10:00am will not be judged.**
- 3. Awards will be given for 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> place as well as Mayor's Choice.**
- 4. Candy must be handed out from participants walking beside floats.  
Participants must hand candy to parade watchers on the sidewalk. No  
candy should be thrown directly from floats.**
- 5. No water balloons, water toys or anything in their likeness should be  
thrown from floats.**
- 6. Floats including horses, mules, donkeys, etc. will have their own  
designated scooper-upper for any mess left behind by the livestock.**
